The purchaser must have the puppy examined by a licensed veterinarian within two (2) business days of the purchase.

**Parties** – Puppy Boutique Store® shall hereinafter be referred as the "Seller." The original purchasing party, and solely the original purchasing party, shall hereinafter be referred to as the "Buyer."

## Guaranteed Contract – Terms and Conditions

Death of Pet Due to Genetically Caused Disease or Sickness:

1. In the event of the death of the pet within 1 year from its birth due to genetics, the Seller shall replace the pet with another of equivalent value at no cost to you or *see Order Form Pet Lemon Law*
2. The Buyer is responsible for the daily health care and maintenance of the pet, including all immunizations and examinations recommended after purchase, as well as providing necessary medication and follow-up treatments from veterinarian visits.
3. The value of the pet for the purpose of this guarantee is solely the original purchase price, not including shipping, and does not include any additional prices declared by the Buyer. Seller sells pets for companion purposed only.
4. In the event this guarantee is exercised, the registration papers must be returned to the Seller.
5. The Sellers grantees the life of the pet for a period of (10) years. / *Genetic & Health Issues*
6. In the event of the death of the pet due to accident, the Seller will issue a kennel credit in the amount of fifty percent (50%) of the original price toward the purchase price of a replacement pet of equivalent value.  
Deductible of \$999 on all breeds except English or French bulldogs deductible is \$1999. If you choose a replacement puppy of greater value than the original purchase price client must pay difference + deductible.
7. In the event of the death of the pet due to accident, a death certificate from a licensed veterinarian must be presented to the Seller within twenty four (24) hours of the accident.
8. The value of the pet of the purpose of this guarantee is solely the original purchase price, and does not include any additional prices declared by the Buyer or shipping. Seller sells pets for companion purposes only.
9. In the event this guarantee is exercised, the registration papers must be returned to the Seller.
10. **Pet Lost or Stolen:** – In the event that the pet is lost or stolen with ten (10) years from the date of birth the Seller will issue a kennel credit in the amount of fifty percent (50%) of the original price towards the purchase price of a replacement pet of the equivalent value. Deductible of \$999 on all breeds except English or French bulldogs deductible is \$1999 If you choose a replacement puppy of greater value than original purchaseprice client must pay difference + deductible
11. In the event that the pet is lost or stolen, the Buyer must advertise the lost pet in a major local newspaper for a period of one week stating twenty four (24) hours after the loss. In additional, the Buyer must notify the police, Humane Society and Animal Control of the loss.

12. The Buyer must present the Seller with copies of: The police report, the advertisement and paid advertisement bill in order to receive this guarantee.
13. The value of the pet for the purpose of the guarantee is solely the original purchase price, and does not include any additional prices declared by the Buyer, or shipping charges.
14. **Fees:** – In the event of any litigation in connection with this Guarantee, will be paid reasonable attorney fees by the purchaser. Venue and jurisdiction for litigation arising out of or related to this contract shall lie exclusively in Broward County, Florida.
15. Registration papers for all registered puppies will be sent by regular mail. If the papers area lost, the purchaser is responsible for the cost of obtaining new papers. However, we will assist you by providing a copy of these papers. It can take up to 6 months to get registration papers.
16. Agreement represents the total agreement between Puppy Boutique Store and the Buyer and no other terms or conditions shall be valid to this Life Insurance program. I, the undersigned, have read this agreement and agree to its conditions in full. The only exception is Bulldogs.
